Blog 2

Objective:

To demonstrate the ability to search and understand the literature around a topic of interest to you, analyze it within a public health framework, and identify an empirical study testing a solution to the problem.

Instructions:

- 1. Topic Selection and Research
- Choose a public health topic you are curious about.
- Conduct outside reading to thoroughly understand the topic.
- Ensure your sources are reliable (avoid Wikipedia). Refer to the provided list of reliable sources.

2. Problem Definition:

- Define the public health problem and describe its scope using epidemiological data from a reliable source.

3. Impact on Specific Group:

- Identify a group that is severely impacted by this problem. For example, obesity affects children differently than adults, and has distinct determinants in low-income neighborhoods or among Native Americans.
- -Note the health impacts of the conditions

4. Application of Public Health Framework:

- Describe a public health framework discussed in class (e.g., social ecological framework, social cognitive theory, health behavior model, etc).
- Use this framework to analyze the social factors contributing to the problem.
- You MUST use a different framework (Cannot use the same framework you described in the first blog)

5. Solution

- Cite one (1 – UNO) empirically tested solution to the problem.

6. Personal Perspective:

- Provide your perspective and thoughts about the solution.

7. Peer Interaction:

- Read and comment on at least one other student's post.
- Ensure your comments are respectful, thoughtful, non-intimidating, and evidence-based, following the same ground rules as in-class discussions.

Word Limit and Penalties:

- The essay must not exceed 500 words. Points will be deducted for exceeding the word limit.

- Late submissions will incur a penalty of .3 points per day.

Citations:

- Use AMA style for citations (refer to [AMA citation guide] (http://guides.lib.uw.edu/c.php? g=99161&p=642357 (http://guides.lib.uw.edu/c.php?g=99161&p=642357))
- Two to three citations are recommended for an essay of this length.

By following these instructions, you will create a well-structured, insightful essay that demonstrates your understanding of public health concepts and frameworks.
